

# END-USER LICENSE AGREEMENT FOR HEDL

(Revision 2013-08-30)

IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE INSTALLING OR USING THIS PROGRAM.

DevBoost GmbH's End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and DevBoost GmbH for the DevBoost GmbH software product HEDL which may include associated software components, media, printed materials, and online or electronic documentation.

By purchasing a HEDL license certificate, by installing, by copying, or using HEDL, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you (referred to as "licensee") and DevBoost GmbH, (referred to as "licensor"), and it supersedes any prior proposal, representation, or understanding between the parties. If you do not agree to the terms of this EULA, do not install or use HEDL.

HEDL is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. HEDL is licensed, not sold.

## 1 GRANT OF LICENSE.

HEDL is licensed as follows:

### (a) Installation and Use.

DevBoost GmbH grants you the right to install copies of HEDL on your computer. To run and use HEDL you require a valid license key. The license key is a unique key-code that enables an Authorized User to use HEDL. Only the licensor and/or its representatives are permitted to produce license keys for HEDL.

### (b) License Certificate

The license certificate is the evidence of a license provided by licensor to licensee in electronic or printed form. A License Certificate may be:

(i) An e-mail from the licensor including a license key and intending to grant or extend the license to use the HEDL.

(ii) A live product subscription using the license server.

(b) Backup Copies.

You may also make copies of HEDL as may be necessary for backup and archival purposes.

(c) Trial License

A trial license grants you a non-exclusive, non-sublicensable, non-assignable, time-limited license to use HEDL according to the terms and conditions of this agreement.

(i) The trial license solely authorises a single natural person to use HEDL.

(ii) The trial period starts as soon as the trial license key is sent to the licensee, and lasts for a limited period of time ("trial period").

(iii) Each licensee is only allowed to evaluate HEDL during a total of one trial period. The trial period can be extended by the licensor on special.

HEDL contains a feature that will automatically disable certain features upon expiration of the trial period. The licensee is not allowed to disable, destroy, or remove this feature.

(d) Commercial License

A commercial license grants you a non-exclusive, non-sublicensable, non-assignable, time-limited license to use HEDL according to the terms and conditions of this agreement.

(i) If the licensee is a legal person, the commercial license only authorizes fixed, named employees of the licensee. Authorisation is granted in terms of personal license key for the respective employees. The licensor can be asked to change an Authorized User under special circumstances.

(ii) The commercial license is granted only for the time period and the number of Authorized Users specified in the license certificate.

(e) Open-Source License and Donated License

An open-source license and a donated license grants you a non-exclusive, non-sublicensable, non-assignable, time-limited license to use HEDL according to the terms and conditions of this agreement.

The open-source license and the donated license is subject to the same terms and conditions as is the commercial license, with the following exceptions:

- (i) With the open-source license you must not use HEDL for purposes other than the development of open-source software, especially not for the development of any commercial software.
- (ii) The licensor can revoke a donated license at any time.

## **2 DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.**

### (a) Maintenance of Copyright Notices.

You must not remove or alter any copyright notices on any and all copies of HEDL.

### (b) Distribution.

You may not distribute licenses or registered copies of HEDL to third parties. Trial versions available for download from DevBoost GmbH's websites may be freely distributed.

### (c) Prohibition on Reverse Engineering, Decompilation, and Disassembly.

You may not reverse engineer, decompile, or disassemble HEDL, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

### (d) Rental.

You may not rent, lease, or lend HEDL.

### (e) Support Services.

DevBoost GmbH may provide you with support services related to HEDL ("Support Services"). Any supplemental software code provided to you as part of the Support Services shall be considered part of HEDL and subject to the terms and conditions of this EULA.

For an unpaid licensee, the licensor will have no obligation to provide support, updates, patches, bug fixes or other enhancements.

### (f) Compliance with Applicable Laws.

You must comply with all applicable laws when using HEDL.

(g) Third party licenses

Some third party software included in HEDL is subject to other licences. These licences are available in the separate file "3rd-party-licenses.txt" included in the HEDL distributions.

### **3 TERMINATION.**

Without prejudice to any other rights, DevBoost GmbH may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of HEDL in your possession.

### **4 COPYRIGHT.**

All title, including but not limited to copyrights, in and to HEDL and any copies thereof are owned by DevBoost GmbH or its suppliers. All title and intellectual property rights in and to the content which may be accessed through the use of the HEDL is the property of the respective content owner and may be protected by applicable copyright or other intellectual property laws and treaties. This EULA grants you no rights to use such content. All rights not expressly granted are reserved by DevBoost GmbH.

### **5 NO WARRANTIES.**

DevBoost GmbH expressly disclaims any warranty for HEDL. HEDL is provided 'As Is' without any express or implied warranty of any kind, including but not limited to any warranties of merchantability, noninfringement, or fitness of a particular purpose. DevBoost GmbH does not warrant or assume responsibility for the accuracy or completeness of any information, text, graphics, links or other items contained within HEDL. DevBoost GmbH makes no warranties respecting any harm that may be caused by the transmission of a computer virus, worm, time bomb, logic bomb, or other such computer program. DevBoost GmbH further expressly disclaims any warranty or representation to Authorized Users or to any third party.

In no event will DevBoost GmbH's liability to the Authorized User, whether in contract, tort (including negligence), or otherwise, exceed the amount paid for the HEDL license. The foregoing limitations will apply even if the above stated warranty fails of its essential purpose.

### **6 LIMITATION OF LIABILITY.**

In no event shall DevBoost GmbH be liable for any damages (including, without limitation, lost profits, business interruption, or lost information) rising out of Authorized Users use of or inability to use HEDL, even if DevBoost GmbH has been advised of the possibility of such damages. In no event will DevBoost GmbH be liable

for loss of data or for indirect, special, incidental, consequential (including lost profit), or other damages based in contract, tort or otherwise. DevBoost GmbH shall have no liability with respect to the content of HEDL or any part thereof, including but not limited to errors or omissions contained therein, libel, infringements of rights of publicity, privacy, trademark rights, business interruption, personal injury, loss of privacy, moral rights or the disclosure of confidential information.

## **7 SEVERABILITY.**

If any provision or provisions of this Agreement shall be held to be invalid, illegal, unenforceable or in conflict with the law of any jurisdiction, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.
